If the actual rental duration ends before the declared rental period, the Lessee will be charged with prices from correspondingly shorter rental periods.

The flat-rate insurance reduces liability for loss or destruction of the rented property and does not apply to civil liability. The flat-rate insurance fee is billed until the Lessee ceases to possess the rented machine.

The flat-rate for charging batteries is a fee for charging batteries before delivery of electrical machine.

The flat-rate for unloading /loading applies to the second and every subsequent machine.

The payment term is: Net 14 days.

mateco will assess the financial credibility of the Customer based on available sources and on this basis may request an advance payment for the rent.

The working height is the maximum platform height plus 2 meters.

All devices have UDT approval.

The rented machine may be operated only by personnel with the license applicable to the rented machine type (valid license UDT, TDT, WDT). The fact is confirmed by the Lessee with a signature underneath.

Signing out procedure shall be performed only in writing, on the basis of a hand over document:

https://www.mateco.pl/fileadmin/pdf/pobierz/Form_Sign_Out_EN.pdf sent to mateco 2 days prior to intended rental period termination. The signed out machine shall be: cleaned, its batteries charged, located in a place allowing for its loading onto a truck. The Lessee is obliged to cover any additional cost of transport due to failure to hand over or collect the machine at the agreed time, for reasons attributable to the Lessee, as well as the rent due from the date of the planned handover of the equipment to the date it has been actually handed over to mateco.

In the case of a fuel drive machine, the Lessee receives the platform filled up with fuel and is obliged to return it refueled. Failure to fulfill the condition will result in the Lessee being charged with the cost of refueling the machine.

The Lessee will be charged with full costs of removal of all damage caused to the machine in the rental period, cleaning off excessive dirt, e.g. paint, plaster etc., or painting work platforms, which has been specified in the acceptance report and on technical examination performed after the equipment has been returned to mateco.

In case of machine failure please contact appropriate mateco branch - arrival of the service personnel up to 12 hours from the notice reception (on weekdays).
